The NRLN Review provides a monthly report on National Retiree Legislative Network actions, events in Congress and important retirement news.

NRLN Action Alert - Allow Importation of Drugs from Canada

For several years the NRLN has lobbied for legislation that would lower the cost of medicines by allowing the importation of safe, lower cost prescription drugs from Canada. An NRLN Action Alert was issued on April 6 requesting that members urge their U.S. Representative and Senators to pass H.R. 832 / S. 259, Safe and Affordable Drugs from Canada Act of 2021.

The bill would require the Food and Drug Administration (FDA) to set regulations within 180 days permitting Americans to import prescription drugs from licensed Canadian pharmacies. The bill stipulates there must be a valid prescription issued by a U.S. physician for drugs for personal use and not greater than a 90-day supply. The drugs must have the same active ingredients, route administration, dosage form and strength as a prescription approved by the FDA.

Few issues have been debated more on Capitol Hill over the past years than prescription drug prices. Talk Is Cheap – Drugs Are Not! Passage of H.R. 832 / S. 259 would help make many prescription drugs more affordable for Americans.

NRLN President's Forum – NRLN Report Card Enhanced

In an April 19 NRLN President's Forum Message, Bill Kadereit thanked Bob Martina, NRLN Vice President – Grassroots, and the Grassroots Committee members Cindy Hadsell and Ray Sternot for their efforts to enhance the NRLN Report Card.

The Report Card, created by the NRLN a few years ago, shows the bills the NRLN is supporting and opposing in the 117th Congress. It shows whether the Senators and the Representatives for a state are a cosponsor of the bills. Few, if any, other retiree organizations provide similar information.

The improvements to the Report Card include using colors to designate whether a legislator is a cosponsor of bills the NRLN supports or opposes. Also, a dash was added to show if a Senator's or Representative's position is unknown on the bill. These changes make it easier for a reviewer of the Report Card to quickly understand if the lawmaker's have taken a position as a cosponsor.

Kadereit urged NRLN members to check the Report Card on their state's Congressional delegation periodically to learn were their Senators and Representative stand on bills the NRLN supports or opposes.

NRLN President's Forum – Advancing Education on Biosimilars Act Passed

President Biden signed into law on April 23 S.164, Advancing Education on Biosimilars Act of 2021, which will help increase competition and lower the cost of biologic medicines.

NRLN President Bill Kadereit sent a letter to House Speaker Pelosi on April 5 requesting that she call for a vote on S.164 which was passed in the Senate on March 3. He stated in his letter "this is an opportunity to get something done immediately."

The House passed the bill on April 14 and sent it on April 20 to the President.

The new law will enhance education about biosimilar drug products in an effort to increase competition and lower the cost of biologic medicines which treat chronic illnesses, such as diabetes, rheumatoid arthritis and certain cancers.

NRLN Legislative Committees' Work

The NRLN's Legislative Advisory Committee (LAC) composed of Judy Stenberg, Chairwoman, Deb Morrissett, Joe Mazzei, Al Duscher and Bob Martina submitted the following bills for the Legislative Action Planning Committee (LAPC) to consider for action during its April 5 conference call. The LAPC composed of Bill Kadereit, Chairman, Alyson Parker, Judy Stenberg, Bob Martina and Ed Beltram made the following decisions.

- **H.R. 832 / S. 259, Safe and Affordable Drugs from Canada Act of 2021** would require the Food and Drug Administration (FDA) to promulgate regulations permitting Americans to import a prescription drug purchased from licensed Canadian pharmacies.
- -- NRLN Action Alert was issued on April 6 to urge Representatives and Senators to pass H.R. 832 / S. 259.
- H.R. 1106, Help Extend Auditory Relief (HEAR) Act of 2021, would provide for Medicare coverage of hearing rehabilitation services and hearing aids.
- -- Letters requesting a vote on **H.R. 1106** in the House Committee on Energy and Commerce were emailed on April 5 to Chairman Frank Pallone (NJ-06) and Ranking Member Cathy Rodgers (WA-05).
- **S. 141, End Taxpayer Subsidies for Drug Ads Act**, would prohibit pharmaceutical drug manufacturers from claiming tax deductions for expenses on advertising directly to consumers. Advertising also increases demand for drugs and allows drug companies to increase prices.
- -- Letters requesting a vote on **S. 141** in the Senate Committee on Finance were emailed on April 5 to Chairman Ron Wyden (OR) and Ranking Member Michael Crapo (ID).
- **S.164, Advancing Education on Biosimilars Act of 2021,** would enhance education about biosimilar drug products in an effort to increase competition and lower the cost of biologic medicines. Independent studies have estimated that biologics could save Americans potentially \$54 billion over 10 years in healthcare costs. The Senate passed S.164 on March 3 and sent the bill to the House.
- -- A letter requesting a House vote on **S. 164** was emailed on April 5 to Speaker Nancy Pelosi. (The House passed the bill on April 14 and the President signed it into law on April 23.)

H.R.599, Protecting Medicare Beneficiaries with Pre-Existing Conditions Act. The LAPC asked Alyson Parker, NRLN Executive Director, to investigate whether this bill expands guaranteed issue rights with respect to Medigap policies (Medicare supplemental health insurance policies) to all beneficiaries regardless of age. (Guaranteed issue rights require that a policy be offered to any eligible applicant without regard to health status.) Or does the bill only provide "guarantee issue" of a Medicare supplemental insurance plan (Medigap) to Medicare beneficiaries under 65 (those who are disabled)? Also, does it only allow Medicare Advantage enrollees switching to traditional Medicare a one-time enrollment in a Medigap plan without underwriting for a pre-existing health condition?

The LAC informed the LAPC on:

- -- S.547 -- a bill to provide relief for multiemployer and single employer pension plans (no action required since this was covered in Public Law 117-2)
- No action required:
 - -- S.589 -- a bill to amend the Internal Revenue Code of 1986 and the Employee Retirement Income Security Act of 1974 to reform the treatment of multiemployer plans, to ensure the ability of the Pension Benefit Guaranty Corporation to provide guaranteed benefits of retirees (similar to the multiemployer language in Public Law 117-2)
- Requires LAPC review but LAC recommends Table and Monitor:
 - -- S.234 -- Americans Giving Care to Elders (AGE) Act of 2021
- Table and Monitor the following COVID-19 bills without white papers:
 - -- H.R.975
 - -- H.R.1677
 - -- S.620
