## **NRLN Members Experienced Social Security Overpayment Clawback**

Twenty-three NRLN members know that Social Security overpayment clawback can happen to anyone – because it happened to them.

On March 11, 2024, the NRLN sent an email to all members requesting that anyone who has had to payback money to Social Security participate in the NRLN's brief survey. The purpose of the survey was to support the NRLN's efforts to change the Social Security Administration's (SSA) regulation on overpayment clawback.

## The Week of March 18-22 Was a Very Good Week for the NRLN – a Winner

Sometimes the NRLN's wins are small and they don't always affect "me" but in our NRLN world, we appreciate every one of them. While this year Social Security and Medicare are at risk and while we have a battle to win protecting annuitized pensions with our de-risking reinsurance proposal, we should also celebrate small steps forward.

The NRLN sent a letter to Martin O'Malley, Social Security Commissioner, pointing out that Congress included an NRLN proposal the Secure 2.0 Act at the end of 2022 that limited the pension recoupment lookback period to three years instead of indefinitely. It also restricted the amount that can be recouped from monthly checks to 10% and extended the payback period instead of demanding it all in short periods of time.

On March 20, CBS published an article noting that the Social Security Commissioner ordered the payback period be extended and that monthly deductions be capped at 10%. The NRLN gave kudos to the Commissioner, confirmed in December, for his quick reaction to address the overpayment clawback problem.

#### **GAO Staff Receives Input from NRLN**

U.S. General Accounting Office staff members who are responsible for doing research and preparing reports for members of Congress and Congressional committees plus testifying at Congressional hearings held a one-hour Zoom call with the NRLN on March 7, 2024.

Five GAO staff members requested input from the NRLN on Medicare and Medicare Advantage. Bill Kadereit, NRLN President, Alyson Parker, NRLN Executive Director, and Ed Beltram, NRLN VP-Communications provided comments.

The main focus of the NRLN's input was that the chronic healthcare subsidized benefits that 31 million Medicare Advantage enrollees receive are denied to the 27 million original Medicare Parts A and B participants. The NRLN believes this denial of benefits to those on Medicare who are, on average, older and more chronically ill must be corrected. There was also discussion about Medicare Advantage plans not being cost competitive with original Medicare.

## NRLN Action Alert – Fiscal Commission Provides Political Cover

There are bills in the House (H.R. 5779, Fiscal Commission Act) and the Senate (S. 3262, Fiscal Stability Act) that the NRLN believes are intended to provide political cover for members of Congress to cut government spending, including possibly placing Social Security and Medicare on the chopping block.

Congress should not pawn off to a 16-member commission – 12 appointed by House and Senate Leaders and 4 nonvoting "outside experts" – who would meet behind closed doors to develop their spending cut recommendations and their proposals would be fast-tracked in Congress, no amendments and only yes or no vote.

## NRLN Legislative Committees' Work

The NRLN's Legislative Advisory Committee (LAC) composed of Judy Stenberg, Chairwoman, Deb Morrissett, Joe Mazzei and Al Duscher prioritizes retirement-related bills it reviews during its twice-a-month conference calls. The LAC submitted the following bills for the Legislative Action Priorities Committee (LAPC) to consider for action.

The LAPC, which includes Bill Kadereit, Chairman, Judy Stenberg, Alyson Parker, Martha Deahl and Ed Beltram, took the actions below on the bills during its March 4 conference call.

The work of the LAC and the LAPC provides the cornerstone for much of the dealings with members of Congress and their staff members.

**H.R.5779/S.3262, Fiscal Commission Act of 2023.** The 16-member commission would hold at least six hearings, including "field hearings" throughout the country and hearings to solicit testimony from the Executive Branch and members of Congress. (The Biden Administration views these commissions as "death panels" for Social Security and Medicare.) The commission's deliberations would be behind closed doors to develop recommendations on how to reduce government spending. Recommendations would be "fast tracked" meaning no amendments in the House or Senate – only yes or no votes.

- -- The NRLN issued an Action Alert on March 6, 2024, asking NRLN members to tell their Representative and Senators that instead of having a fiscal commission, current Congressional committees and their members should step up and be held accountable for reduced spending recommendations.
- **H.R.6860, Restore Protections for Dialysis Patients Act**. Roughly 37 million Americans live with chronic kidney disease (CKD), and of those 37 million, more than 800,000 have seen their condition progress to end-stage renal disease (ESRD), also known as kidney failure.
- **H.R. 6860** would restore the Medicare Secondary Payer Act (MSPA) protections for ESRD patients by ensuring that private health plans do not discriminate against such patients or adversely classify dialysis as compared to other covered medical services.

The bill aims to ensure that individuals with ESRD continue to have equitable access to private healthcare and to provide protection of the Medicare Trust Fund. The legislation follows a 2022 Supreme Court ruling that has allowed private health plans to prematurely force ESRD patients onto Medicare, creating disruption in coverage for patients and their families and shifting a significant financial burden onto taxpayers.

- -- On March 6, NRLN President Bill Kadereit sent a letter to Representative Mike Kelly (PA16) to thank him for introducing **H.R.6860** and requesting that if he has not already done so to reach out to a Senator to request the introduction of a companion bill.
- H.R.6961/S.3010, Nutrition CARE (Counseling Aiding Recovery for Eating Disorders) Act of 2023/2024, would expand access to care for Medicare beneficiaries with eating disorders by including coverage of outpatient medical nutrition therapy through Medicare Part B. Medical nutrition therapy (MNT) is the process of providing treatment and recovery around food and nutrition from a registered dietitian to address the complex nature of eating disorders. However, MNT is not currently covered for eating disorders under Medicare Part B. This lack of coverage leaves the full scope of treatment out of reach for seniors and people with disabilities with eating disorders.
- -- On March 6, NRLN President Bill Kadereit sent letters to House Committee on Ways and Means Chairman Jason Smith (MO08) and Ranking Member Richard Neal (MA01) and House Committee on Energy and Commerce Chair Cathy McMorris Rodgers (WA05) and Ranking Member Frank Pallone (NJ06) requesting votes in the Committees for **H.R6961**.
- -- On March 6, NRLN President Bill Kadereit sent letters to Senate Committee on Finance Chairman Ron Wyden (OR) and Ranking Member Mike Crapo (ID) requesting a vote in Committee on **S.3010**.
- **S.3109, Alleviating Barriers for Caregivers (ABC) Act** would require the Centers for Medicare and Medicaid Services (CMS), Social Security Administration (SSA), and Children's Health Insurance Program (CHIP) to review their eligibility, processes, procedures, forms, and communications to reduce the administrative burden on family caregivers. The legislation would then annually require CMS, SSA and CHIP to report to Congress about any issues they are facing and any next steps they are taking to support family caregivers.
- -- On March 6, NRLN President Bill Kadereit sent letters to Senate Committee on Finance Chairman Ron Wyden (OR) and Ranking Member Mike Crapo (ID) requesting a vote in Committee on **S.3109**.

- H.R.6683 -- Preserving Seniors' Access to Physicians Act of 2023
